We would like to bring to your attention that, pursuant to internal reorganization, our company Pompes Salmson SAS will be absorbed on November 1st 2013 by its parent company, Wilo Salmson France (simplified joint stock company with a capital of € 26.417.514, headquartered at 53, boulevard de la République in Chatou (78400), registered at the Versailles Trade and Companies register under number 410 615 900, and VAT number: FR 92 410615900). As a result, all assets and liabilities within our operations will be allocated to Wilo Salmson France SAS as from November 1st 2013.

Under the terms of the merger agreement between Pompes Salmson SAS and Wilo Salmson France SAS, Wilo Salmson France SAS will assume, by this date, all existing obligations owed to third parties and will substitute totally to Pompes Salmson SAS' engagements.
